Entry Fee: TD \$80, TDX \$120 (includes AKC recording and service fees) in US funds to "HVTC, Inc." If paying in Canadian currency, please add \$7.50 for bank processing charges

Prizes: HVTC, Inc. will award a rosette, glove, and HVTC start flag to all passing TDs. A rosette and plaque will be awarded to passing TDX dogs. Special prizes: See catalog.

Bitches in Season – Bitches in season will be allowed to participate in accordance with Chapter 2, Section 8 of the AKC Tracking Regulations. Please note that the Test Secretary must be notified that a bitch is in season prior to the drawing for tracks. Bitches in season will be allowed to participate in a test only after all the other dogs and bitches not in season have been tested.

Drawing for Entries – A drawing for entries will be conducted in accordance with Chapter 1, Section 12 of the AKC Tracking Regulations, and will be held at the Test Secretary's home on Thursday, Sept. 23 at 5pm. The drawing will be at random except that preference for the TD shall be given to those dogs that have not earned a TD and preference for the TDX shall be given to dogs that have not earned a TDX. There will be an alternate list with positions assigned according to the order in which they were drawn. Observers are welcome. The Test Secretary will notify all entries of the results by e-mail.

Withdrawals and Entry Fee Refunds – If an entry withdraws between the closing date and the test date, and is replaced by an alternate, the entry fee will be refunded. Withdrawals must be made in writing to the Test Secretary. The entry fee for an alternate that does not participate will be refunded.

Directions: New York State Thruway (interstate 87) to exit #18. Go west (left) on route 299 through New Paltz. Continue on route 299 over bridge as you leave town. From the bridge it is 1.2 miles to Gatehouse Rd on your right. Turn right, proceed 0.7 miles to a dirt driveway on the left, next to a red barn.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
